

# **Oude Westhof Masters Home Owners Association**

#### **GENERAL BUILDING AND ALTERATIONS PROCEDURES GUIDE**

A "Certificate To Commence Building" issued by the Association is required before any building commences.

In order to issue a "Certificate to Commence Building" the Association has put the following procedure in place.

- 1. Plans to be submitted via e-mail, in pdf format, to NOLANDS INCORPORATED (Managing Agent) for approval.
  - Nolands Incorporated will forward your plans to the CONTROLLING ARCHITECT Maryke Maree Architects.
  - The Controlling Architects will bill you for their services.
- 2. Once approved your plans will be e-mailed by the Controlling Architect to Nolands Incorporated and the erf owner.
- 3. A copy of the plans approved by Maryke Maree Architects and the local authority should then be e-mailed to Nolands Incorporated and Maryke Maree Architects.

### Before building can commence

- All building annexures must be signed by the erf owner and returned to the Association
- A refundable building deposit needs to be paid to the Associations Building Deposit Account as follows:
  - R5 000.00 for alterations
  - R15 000.00 for a new home
- Details of starting date and expected completion date to be sent to the Association by erf owner.
- The Association will then issue a Certificate To Commence Building that must be signed and returned to the Association. A copy must be left with the person in charge of the building site.
- The Associations building inspector issues reports to Nolands Incorporated and the Architectural Trustee on a regular basis.
  - Nolands Incorporated will then e-mail the report to the erf owner.
- Once the building process is complete kindly request a final inspection via e-mail.
- Please note that a copy of your Occupation Certificate must be e-mailed to Nolands Incorporated before your building deposit will be refunded.
